BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following

nominees shall be submitted to the governor for his consideration for final appointment to fill the vacancy on the Jackson County Sports Complex Authority occasioned by the expiration of the term of Jerry Mackey, for a new term to expire July 15, 2008:

- B. Charlie Franklin
- C. Jerry Mackey

BE IT FURTHER RESOLVED that the Clerk of the Legislature be and hereby is directed to submit this panel to the governor by providing him a true and correct copy hereof.
