ORDINANCE #3688, October 3, 2005

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RE" (Residential Estates) District, so that there will be transferred from District A to District RE, a tract of land described as follows:

The Legislature, pursuant to the application of Arthur Kottman (RZ-2005-379), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plate Commission voted 5 to 1 recommended approval of this application in a public hearing on Septemb 15, 2005, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
