WHEREAS, the Department of Public Works desires to make road improvements on Liggett Road from Lake Jacomo Dam to the Blue Springs City limits in Project No. 2449; and,

WHEREAS, the Missouri Highway Transportation Commission ("MHTC"), has proposed to provide

partial reimbursement for these improvements under a Surface Transportation Agreement, STP-1204
(401), a copy of which is attached hereto; and,
WHEREAS, under this Agreement, the County will pay the up front costs for the project at an
estimated cost of \$2,200,000.00 and upon acceptance of the completed project, the MHTC will
forward the County a federal reimbursement check for the total sum of \$1,282,800.00 in fiscal year
2010; and,
WHEREAS, the Acting Director of Public Works recommends execution of the Agreement; now
therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the County Executive
be and hereby is authorized to execute the attached Agreement with MHTC.
