WHEREAS, the Missouri Department of Transportation, Highway Safety Division, has awarded the Sheriff's Office an "Occupant Protection" grant in the amount of \$6,000.00 for the period October 1, 2009, through September 30, 2010; and,

WHEREAS, these funds will allow the Traffic Safety Unit to schedule special Click It or Ticket

campaigns locally, as well as to participate with statewide projects throughout the year; and,

WHEREAS, the goal is to increase motorist use of safety restraints and to ultimately save more lives; and,

WHEREAS, the Sheriff recommends the use of the grant funds for reimbursement of overtime used for the "Occupant Protection" program; and,

WHEREAS, an appropriation is necessary to place the grant funds in the appropriate spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the fund balance of the 2009 Grant Fund:
