**ORDINANCE NO. 4960**, March 20, 2017

**INTRODUCED BY** Dan Tarwater III, County Legislator

WHEREAS, by Ordinance 4865, dated July 18, 2016, the Legislature authorized the acceptance of a grant provided by the Organized Crime Drug Enforcement Task Force (OCDETF) to conduct a joint federal drug investigation in conjunction with the Jackson County Drug Task Force, OCDETF Case No. WC-MOW-306, Operation Squeaky Banjo, for the period of October 1, 2015, through September

30, 2016; and,

WHEREAS, by Ordinance 4921, dated October 31, 2016, Ordinance 4934, dated November 21, 2016, and Ordinance 4959, dated February 27, 2017, the Legislature did authorize the appropriation of additional funding received from the OCDEF toward this operation; and,

WHEREAS, the OCDEF has authorized additional funding for the reimbursement of overtime related to this operation, in the amount of \$5,000.00; and,

WHEREAS, an appropriation is necessary to place the additional funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the undesignated fund balance of the 2017 Anti-Drug Sales Tax Fund be and hereby is made:
