ORDINANCE #4224, August 16, 2010

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, the Family Court Division has entered into a reimbursement agreement with the Independence School District ("District") for the period January 1, 2010, to December 31, 2010, pursuant to which the District will provide funds to the Family Court Division for staffing the Truancy Court Project; and,

WHEREAS, the Truancy Court Project addresses the problem of unexcused absences of student probationers including the assessment of truancy cases in general; and,

WHEREAS, an appropriation is necessary to place the funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the fund balance of the 2010 Grant Fund:
