WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Medical Examiner and the

Director of Finance and Purchasing recommend the award of a twenty-four-month term and supply contract, with one twelve-month option to extend, for the furnishing of body bags for use by the Medical Examiner's Office to Frontier Mortuary Supply, LLC, as the overall best bid; and,
