WHEREAS, the Kansas City Metropolitan Crime Commission (KCMCC) has awarded a grant to the Prosecuting Attorney's Office in the amount of \$110,000, for its Project Safe Neighborhoods program,

which the County will use to fund two prosecutors to assist KCMCC in the prosecution of federal and/or state criminal charges related to firearms crimes; and,

WHEREAS, this grant is a pass-through of funds received from the United States Department of Justice; and,

WHEREAS, this grant is subject to a local match in the amount of \$19,255; and,

WHEREAS, a transfer and appropriation are necessary to place the matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,
