WHEREAS, the Family Court Division has been awarded a grant in the amount of \$68,317.06 by the

Missouri Department of Social Services, Division of Youth Services, for the period of July 1, 2009, through June 30, 2010; and,

WHEREAS, the grant funds will be used to fund the After School Supervision Education & Treatment (ASSET) Equipping for the Future Program, which provides academic and skill building activities when the highest rate of recidivism occurs for the delinquent population; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; now therefore,
