**INTRODUCED BY** Dennis Waits, County Legislator

WHEREAS, the County has determined that there is a need to address the ongoing problem of increased lethal violence in the community; and,

WHEREAS, the Office of the Prosecuting Attorney has recommended a project which includes the production and airing of anti-violence public service announcements and distribution of related materials; and,

WHEREAS, there remains a nexus between the current violence problem and drug-related crimes which justifies the use of Anti Drug Sales Tax Fund monies for a portion of this project; and,

WHEREAS, O'Neill Communications has agreed to produce the anti-violence public service announcements and related materials for use by the County and the COMBAT program for this project at a cost to the County not to exceed \$16,830.00; and,

WHEREAS, a transfer of \$13,464.00 within the 2005 Anti-Drug Sales Tax Fund and \$3,366.00 within the 2005 General Fund is required to place the monies in the proper spending accounts for use by the Office of the Prosecuting Attorney for this project; and,

WHEREAS, the Administration recommends these transfers; and,

WHEREAS, the term of the Agreement with O'Neill Communications will run from October 10, 2005 and continue through November 10, 2005; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfers be and hereby are made:
