WHEREAS, in connection with the Jackson County Detention Center expansion, the Purchasing Director has solicited formal written bids on Bid No. PW-2345 (Bid Package No. 7) for the furnishing and installation of electrical and security systems for the expansion at the Jackson County Detention Center; and,

WHEREAS, he has received as the lowest three bids thereon bids from the following:

WHEREAS, the Purchasing Director makes no recommendation regarding the award of this contract; and,

WHEREAS, in the event that change orders to the contract become necessary, due to the time constraints involved in completion of this phase of work, it is appropriate that the County Executive be given authority to approve additional expenditures under this contract not to exceed 5% of the contract amount; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that a contract on Bid No. PW-2345 (Bid Package No. 7) in the actual amount of \$2,102,330.00, be awarded to R. F. Fisher Electric Co. of Kansas City, KS, as the lowest and best bidder; and,

BE IT FURTHER RESOLVED that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the County Executive is authorized to approve additional expenditures which may become necessary under this contract in an amount not to exceed \$10,500.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, except final payment on the contract.
