WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 86-01 for the design and construction of a stand-alone sanitary sewer system for use by the Parks and Recreation Department at Fleming Park; and,

WHEREAS, the only bid received meeting specifications was from White Cloud Engineering of Maryville, MO; and,

WHEREAS, the Purchasing Director has recommended that award be made to White Cloud

Engineering of Maryville, MO, for the reason that it has submitted the lowest and best bid meeting specifications; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
