WHEREAS, he has received as the only bid thereon a bid from Coffelt Land Title, Inc. of Harrisonville, MO; and,

WHEREAS, the Purchasing Director has recommended that award be made to Coffelt Land Title, Inc., of Harrisonville, MO, for the reason that it has submitted the lowest and best bid; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby,

authorized to execute for the County any documents necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract thereby made, to the extent that sufficient appropriations to the using spending agencies are contained in the then current Jackson County budget.
