INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the voters of Jackson County, Missouri, approved imposition of the sales tax for seven (7) years to provide funding for the fight against illegal drugs in our community; and,

WHEREAS, the Legislature authorized local matching funds through Ordinance 2373; and,

WHEREAS, the Kansas City Housing Authority (KCHA) has received a grant from the Department of Housing and Urban Development in the amount of \$459,000, for the following programs:

Youth Entrepreneur Program;

ii. Shadow Box II Program; and

iii. Recreational Program

and;

WHEREAS, the KCHA has requested matching funds in the amount of \$59,514.12 to implement the program; and,

WHEREAS, the Prosecuting Attorney has reviewed this request and recommends funding in the amount of \$59,514.12; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Prosecuting Attorney is hereby authorized to execute the attached agreement with the Kansas City Housing Authority; and

BE IT FURTHER RESOLVED that the manager of the Division of Finance is hereby authorized to make all payments, including final payment on this Agreement...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
