BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature proclaims May 16-22, 2004, as National Public Works Week in Jackson County, and calls upon all citizens and civic organizations to acquaint themselves with the issues involved in providing our public works and to recognize the contributions which public works employees make everyday to our health, safety, comfort, and quality of life.
