INTRODUCED BY Robert A. Stringfield, County Legislator

WHEREAS, the Jackson County Circuit Court, Family Court Division recommends entry into a new Supplemental Agreement for Family Court Staff with the Missouri Department of Social Services, Division of Child Support Enforcement for the period July 1, 2004, through June 30, 2005; and,

WHEREAS, this Agreement provides the mechanism by which certain costs incurred by the Family

Court Division can be reimbursed to the County by the Division of Child Support Enforcement; and,

WHEREAS, this Agreement is in the best interests of the health, welfare, and safety of the citizens of the County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be, and hereby is, authorized to execute the attached Supplemental Agreement for Family Court Staff with the Missouri Department of Social Services, Division of Child Support Enforcement.
