WHEREAS, in an effort to support professional management for Jackson County, the County Executive recommends an employment agreement for this top-level management position with the County; and,

WHEREAS, this agreement outlines the basis for continued employment, termination, and severance, a practice that is recommended by the International City/County Management Association and

WHEREAS, the execution of this Employment Agreement is in the best interests of the health,
welfare, and safety of the citizens of Jackson County; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive
be and hereby is authorized to execute the attached Employment Agreement on behalf of the County; and
BE IT FURTHER RESOLVED that all County officials be and hereby are authorized to undertake all actions required by this Agreement.
