INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the YMCA of Greater Kansas City's "Blue Hills Together Americorps" program is a nationally recognized program whose efforts increase public safety; and,

WHEREAS, the YMCA of Greater Kansas City has received a state grant from the Missouri Community Service Commission in the amount of \$258,300.00, as well as an in-kind contributions from YouthNet in the amount of \$1,300.00, and Kansas City Neighborhood Alliance in the amount of \$6,250.00, and the YMCA has pledged cash and in-kind contributions in the amount of \$111,434.00, for this program; and,

WHEREAS, the YMCA of Greater Kansas City has requested anti-drug sales tax matching funds in the amount of \$64,575.00 to continue the program; and,

WHEREAS, the Prosecuting Attorney has reviewed this request and recommends funding in the amount of \$64,575.00 from her grant match account; therefore.

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to execute the attached Agreement with the YMCA of Greater Kansas City; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is hereby authorized to make all payments, including final payment on the Agreement...Attorney
