WHEREAS, the County and Missouri Department of Social Services desire to extend said agreement through June 30, 1999; and,

WHEREAS, the attached amendment to agreement for these services has been suggested by the Department of Social Services and approved by the County Counselor; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached amendment to agreement is hereby approved, and that the County Executive be and hereby is authorized to execute the amendment to agreement on behalf of the County.
