WHEREAS, by Resolution 15519, dated June 13, 2005, the Legislature did award twelve-month term and supply contracts for the furnishing of mattresses, bedding, and linens for use by the Corrections Department to Bob Barker Co. of Fuquay Varina, NC, ATD-American Co. of Wyncote, PA, and Tabb

Textile Co. of Opelika, AL, to provide for departmental needs, under the terms and conditions of Electronic Solicitation BB200511; and,

WHEREAS, due to an administrative error, the items awarded by Resolution 15519 to ATD-American Co. and Tabb Textile Co., on which they were the respective low bidders, were inadvertently transposed; and,

WHEREAS, the Director of Finance and Purchasing recommends that award to these two vendors be corrected as follows:

BE IT FURTHER RESOLVED that the portion of Resolution 15519, dated June 13, 2005, that awarded contracts to Tabb Textile Co. of Opelika, AL, and ATD-American of Wyncote, PA, be and hereby is rescinded.
