WHEREAS, the County Counselor recommends that he be authorized to execute Legal Services Agreements and an Addendum to an existing Legal Services Agreement with certain lawyers and law firms to provide legal services to the County in certain new and ongoing matters; and,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is authorized to execute Legal Services Agreements and an Addendum to the existing Legal Services Agreement with the lawyers and/or law firms identified in this Resolution, for a term ending December 31, 2021, at an aggregate cost to the County not exceed \$177,000.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance and Purchasing be and hereby is authorized to make all payments, including final payments, on the Agreements and Addendum.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
