WHEREAS, the Assessment Department has a need for an independent audit to examine the

department's current processes and procedures to improve the department's ability to serve the citizens of the County; and,

WHEREAS, pursuant to section 1030.1, Jackson County Code, 1984, the Director of Assessment and Director of Finance and Purchasing recommend the award of a contract for the furnishing of the needed auditing services to the International Association of Assessing Officers (IAAO) of Kansas City, Missouri, as a sole source purchase, for the reason that IAAO is the only local vendor experienced in assessment issues that can provide the needed services;

WHEREAS, a transfer is necessary to place the needed funds in the proper spending account; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be and hereby is made within the 2021 Assessment Fund:
