BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the County Executive is authorized to execute an agreement with the Twelfth Street Heritage Development Corporation for funding of predevelopment and personnel costs not to exceed \$25,000.00; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to make all payments, including final payment on the agreement...Attorney
