INTRODUCED BY Ronald E. Finley, County Legislator

WHEREAS, Section 141.750.2, RSMo 2000, authorizes the Trustees of the Land Trust of Jackson County to convey title in fee simple for consideration less than two-thirds of the appraised value of a property only after the consent of at least two of the Trustees' appointing authorities; and,

WHEREAS, the Trustees have recommended that certain properties in the urban core, be conveyed to various public entities and neighborhood associations including <u>HEDFC</u> and <u>K.C. Acquisitions</u>, <u>LLC</u> to support the construction and rehabilitation of residential properties as well as the
