RESOLUTION 12668, April 19, 1999

INTRODUCED BY Victor E. Callahan, County Legislator

WHEREAS, section 137.335, RSMo 1994, requires the County Assessor, or corresponding officer in Jackson County, the Manager of the Division of Finance, to complete the assessment list of real and personal property for tax purposes by May 15 of each year; and,

WHEREAS, said requirement may be extended for good cause shown to May 31 by order of the governing body of the County; and,

WHEREAS, the Manager of the Division of Finance has informed the Legislature that, due to the volume of assessments necessary, the 1999 assessment list may not be completed prior to May 15; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the Manager of the Division of Finance be and hereby is granted until May 31, 1999, to complete the 1999 assessment list of real and tangible personal property in the County.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
