WHEREAS, by Resolution 15358, dated January 18, 2005, the County awarded a twenty- four month term and supply contract for the furnishing of inmate food service for use by the Department of Corrections to ABL Management, of Baton Rouge, LA, under the terms and conditions of Bid No. 60-04, as the best bidder; and,

WHEREAS, the Director of Finance and Purchasing now recommends a twenty-four month extension of the contract with ABL Management, of Baton Rouge, LA, commencing February 1, 2007, and terminating January 31, 2009, under the terms and conditions of Bid No. 60-04; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the extension be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents necessary for the accomplishment of the extension; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance and Purchasing is authorized to make all payments, including final payment on the contract and extension, to the extent that sufficient appropriations to the using spending agency are contained in the then current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
