INTRODUCED BY John C. Graham and Fred Arbanas, County Legislators

WHEREAS, Rachel Diekmann, high school senior at Lee's Summit High School, has been named the Kansas City Star's All-Metro girls basketball player of the year; and,

WHEREAS, standing 6'1", Rachel has completed an outstanding four-year career as a center for the Tigers; and,

WHEREAS, out of 28 games played this season, Rachel averaged 22.5 points per game; and,

WHEREAS, Rachel's shooting percentage was 56.6, and 72.8 for free throws, and she scored 630 points in the 1998 season; and,

WHEREAS, Rachel gathered 233 rebounds, averaging 8.3 per game, with 1.5 assists per game, and 32 steals and 52 blocked shots in the season; and,

WHEREAS, this 4-year letterman scored 1,767 points during her career, with 51 of those points scored in one game, setting a school record; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature congratulates Rachel Diekmann upon being named the Kansas City Star's All-Metro girls basketball player of the year and upon her illustrious 4-year basketball career at Lee's Summit High School.
