WHEREAS, the United States Department of Justice has granted permission to extend the time for completion of expenditures authorized by the Drug Court Enhancement Grant project, through June 30, 2001; and,

WHEREAS, this extension will allow for time to support daily operations and expenses for the Judge Mason Center; and,

WHEREAS, a transfer within the 2001 Anti-Drug Sales Tax Fund is necessary to cover lease expenses for the Judge Mason Center, at a rate of \$4,837.69 per month; and,

WHEREAS, the County Executive recommends said transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be and hereby is made within the 2001 Anti-Drug Sales Tax Fund:
