WHEREAS, Missouri Constitution, article X, section 6 and section 139.600, RSMo 2000, provide for a tax levy to be charged against the assessed valuation of real property listed in subclass 3 (utility, industrial, commercial and railroad property) of class one property (real estate), to replace revenues lost from the exemption of merchants' and manufacturers' inventories; and,
