WHEREAS, Jackson County and the Independence Emergency Operations Center received the "Partners in Preparedness Award" from the International Association of Emergency Managers-USA for the "Faith-Based Preparedness Program," which is a collaborative effort between Jackson County, the Independence Emergency Operations Center and local faith organizations focused on the communication of emergency preparedness issues and education; and,

WHEREAS, Jackson County Emergency Preparedness and Homeland Security Department Director, Michael Curry, is a finalist for the National Emergency Manager of the Year for 2009, and was named as Governor Nixon's Co-Chair for the State of Missouri's Faith Based Initiative Roll Out and Kick Off; and.
