WHEREAS, the Prosecuting Attorney's Office has been awarded a grant in the amount of \$36,902.46 by the Missouri Department of Public Safety for the office's Victim Services Program for the period October 1, 2009, through September 30, 2010; and,

WHEREAS, a match of \$9,225.62 is required for this grant; and,

WHEREAS, in order to complete the project, the Prosecutor's Office requires an additional \$8,028.00; and,

WHEREAS, a transfer and appropriation are necessary in order to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,
