WHEREAS, pursuant to §64.930, RSMo, 2000, and case law construing said section, in the event a vacancy exists, a panel of three names shall be submitted by majority vote of the county legislative body to the governor for appointment; and,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following names shall be submitted to the Governor for his consideration for final appointment to fill the vacancy on the Jackson County Sports Complex Authority occasioned by the expiration of the term of Richard Berkley, for a new term to expire July 15, 2005:

- B. John Graham
- C. Michael B. Smith
