RESOLUTION #12486, December 15, 1998

INTRODUCED BY Dixie M. Flynn, County Legislator

WHEREAS, Section 1040.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with West Publishing Co. of St. Paul, MN, for the furnishing of law books; and,

WHEREAS, the Purchasing Director further recommends that it not take competitive bids with regard to said contract for the reason that West Publishing Co. of St. Paul, MN, is the only supplier of the law books needed; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the Purchasing Director be, and hereby is, authorized to execute for the County a contract with West Publishing Co. of St. Paul, MN, for the furnishing of law books, in an amount not to exceed \$6,122.60; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments including final payment on the contract thereby made...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
