WHEREAS, this approval is in the best interest of the health, safety and welfare of the citizens of

Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the request of the

Independence Chamber of Commerce be and hereby is approved and that the County Executive is

hereby authorized to execute the attached agreement with the Independence Chamber of

Commerce.
