**AN ORDINANCE** appropriating \$25,000.00 from the fund balance of the 2010 General Fund to cover the cost of architectural and engineering services to remodel portions of the 9<sup>th</sup> floor of the downtown Kansas City Courthouse to create a second Probate Division courtroom.

**ORDINANCE #4264**, October 25, 2010

**INTRODUCED BY** James D. Tindall, County Legislator

WHEREAS, the Circuit Court has requested the County explore the possibility of providing a second courtroom for the probate division; and,

WHEREAS, the conceptual plan will reconfigure areas of the 9<sup>th</sup> floor of the downtown Kansas City Courthouse to allow all probate functions to be consolidated on one floor, to better meet the Probate Division's needs; and,

WHEREAS, an appropriation is necessary to cover the cost of architectural and engineering services to develop a specific plan and cost estimates for the construction; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the fund balance of 2010 General Fund be and hereby is made:
