INTRODUCED BY Henry C. Rizzo, County Legislator

WHEREAS, section 137.335, RSMo 2000, requires the County Assessor, or corresponding officer in Jackson County, to complete the assessment list of real and personal property for tax purposes by May 15 of each year; and,

WHEREAS, said requirement may be extended for good cause shown to May 31 by order of the

governing body of the County; and,

WHEREAS, the Director of Assessment has informed the Legislature that, due to the volume of assessments necessary, the 2005 assessment list may not be completed prior to May 15; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the Director of Assessment be and hereby is granted until May 31, 2005, to complete the 2005 assessment list of real and tangible personal property in the County.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
