WHEREAS, the County has received payments from Liberty Mutual Insurance Company and American Family Insurance Group representing repair costs of two Sheriff's Office vehicles damaged as a result of two separate motor vehicle accidents occurring on February 8, 2013, and February 5, 2013; and,

WHEREAS, an appropriation is necessary to place the restitution payment in the proper spending

account so that the funds may be used to repair the vehicle; now therefore,
