WHEREAS, the County and the Kansas City Area Development Council desire to enter into an agreement, a copy of which is attached hereto and incorporated herein, whereby the Council will provide said information; and,

WHEREAS, the cost to the County under this agreement is \$15,000.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the agreement is hereby approved and that the County Executive is authorized to execute the agreement on behalf of the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
