WHEREAS, the County and the Mid-America Regional Council (MARC) desire to enter into a Cooperative Agreement, a copy of which is attached hereto and incorporated by reference herein, whereunder the County will pay MARC \$5,945.00 to be used to discharge responsibilities related to MARC's designation by the County as its Local Emergency Planning Committee under the Federal Emergency Planning and Community Right-to-Know Act (Superfund Amendment and Reauthorization Act of 1986 - Title III); therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Agreement is hereby approved and that the County Executive is authorized to execute the Agreement on behalf of the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the Agreement...Attorney
