WHEREAS, pursuant to Resolution 15816, dated March 13, 2006, the County, the City of Blue Springs, and Blue Springs School District No. 4 entered into an Intergovernmental Cooperative Agreement to equally share all costs incurred for the re-design and construction of North-South

Liggett Road, Project No. 3053; and,

WHEREAS, the Director of Public Works has received documentation of Project expenses incurred by the Blue Springs School District; and,

WHEREAS, under the Intergovernmental Cooperative Agreement, the County's share of said expenses is \$14,000.00; and,

WHEREAS, the Director of Public Works recommends the issuance of a one-time lump sum payment of \$14,000.00 payable to the Blue Springs School District; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of the Department of Finance and Purchasing be and hereby is authorized to issue a one-time lump sum payment of \$14,000.00 payable to the City of Blue Springs, Blue Springs School District No. 4, in conjunction with improvements to North-South Liggett Road, Project No. 3053.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
