ORDINANCE #4067, December 1, 2008

INTRODUCED BY Theresa Garza Ruiz, County Legislator

WHEREAS, the Family Court Division has entered into a reimbursement agreement with the Independence School District for the period June 15, 2008, to December 31, 2008, pursuant to which the district will provide the division funds for staffing for the Truancy Court Project; and,

WHEREAS, the Truancy Court Project addresses the problem of unexcused absences of student probationers including the assessment of truancy cases in general; and,

WHEREAS, an appropriation is necessary to place the funding in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the fund balance of the 2008 Grant Fund:
