WHEREAS, the Kansas City Metropolitan Crime Commission (KCMCC) has awarded a grant to the Prosecuting Attorney's Office in the amount of \$10,940.00, for its Project Safe Neighborhoods program, which the County will use to fund one full-time prosecutor to assist in the prosecution of

WHEREAS, this grant is subject to a local match in the amount of \$21,137.00; and,
