WHEREAS, the Parks and Recreation Department has been awarded a grant by the Missouri Department of Natural Resources in the amount of \$58,650.00, to pay for the development of a bicycle and multi-purpose trail at the Blue Springs Lake; and,

WHEREAS, a transfer and appropriation are necessary to place the grant and matching funds in the appropriate accounts; and,
