WHEREAS, the owners have agreed to convey said right-of-way, and to settle the claim for damages and have executed a conveyance in favor of the County in consideration of the total payment of \$2,150.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of the Department of Finance issue a check in the amount of \$2,150.00 in the name of Clifford L. and Goldie F. Lee, and that the check be delivered to the Department of Public Works, c/o Martha Poe, Engineering Division, for appropriate disposition...Attorney
