AN ORDINANCE amending the districts established by the Jackson County Zoning Order by changing from A (Agricultural) to GB (General Business), a certain 8.5 ± acre tract.

## **ORDINANCE #3230**, March 4, 2002

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "GB" (General Business) District so that there will be transferred from District A to District GB a tract of land described as follows:

**Description:** A 8.5 ± acres of land generally located at the southeast corner of Missouri 7 Highway and Missouri 150 Highway and specifically described as:

A tract of land in the Northwest Quarter of Section 29, Township 47 North, Range 30 West in Jackson
