WHEREAS, the attached License and Professional Services Agreement sets out the rights and obligations of the parties; therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and is authorized to execute the attached License and Professional Services Agreement with the University of Missouri at Kansas City...Attorney
