ORDINANCE #2469, October 23, 1995

WHEREAS, the County has been awarded a grant in the amount of \$1,145,507.00 from the Missouri Department of Corrections to fund the County's CJ Treatment Network Program; and,

WHEREAS, this grant is subject to a \$50,000 local match; and,

WHEREAS, a transfer within and an appropriation from the unappropriated surplus of the 1995 Anti-Drug Sales Tax Fund are necessary to place the grant and matching funds in the proper accounts; and,

WHEREAS, the County Executive recommends this transfer; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer be made within and appropriation be made from the unappropriated surplus of the 1995 Anti-Drug Sales Tax Fund:
