INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the Jackson County Drug Task Force and Paul Campo of Williams & Campo, PC, desire to enter into an Agreement that Paul Campo serve as legal advisor to the Drug Task Force; and,

WHEREAS, under this Agreement, Paul Campo shall have the duty to attend Task Force meetings,

provide legal advice, draft contracts and documents as needed by the Task Force, and provide such other legal services as may be required; and,

WHEREAS, Paul Campo shall be paid for his services at the rate of \$145.00 per hour, in a total amount not to exceed \$10,000.00, for the period of January 1, 2011, through December 31, 2011; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be, and is hereby, authorized to execute an Agreement with Paul Campo of Lee's Summit, MO, in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments including the final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
