RESOLUTION #12645, April 6, 1999

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, the Parks and Recreation Department has applied to the Jackson County Board of Services for the Developmentally Disabled for funding assistance for the Department's Special Recreation Division; and,

WHEREAS, the Board has agreed to provide a maximum sum of \$13,219.00, to assist the Division with its day skills program; and,

WHEREAS, execution of an agreement with the Board is in the best interest of the health, safety, and welfare of the citizens of the County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute a contract with the Jackson County Board of Services for the Developmentally Disabled in a form as approved by the County Counselor.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
