WHEREAS, in his passionate crusade to help these youth, Melvin coordinated youth sports tournaments, served as program director in many events concerning youth, and participated in AMERICORP; and,

WHEREAS, Melvin also served as coordinator and participant in the Million Man March and was last employed by Drive By Agony of Lynnwood, California; and,

WHEREAS, Melvin is survived by his wife Marlayne, son and daughter Matias and M'Kaylah, parents Lucille E. Moore-Denmon (Jackson County Information Desk Receptionist) and Marion C. Denmon, sister and brother-in-law Loretta and Jerry Petty, sister and brother-in-law Lelia and Collin Dietiker, father and mother-in-law Charles and Melba Myers, nephews Antoine LaMont Nance and Darris Pouncil, nieces Estella Nicole Pace, DeAndra Boyd, and Amaris Washington, and other family members; and,
